
## **CIVICA ENGAGE TRACK PROGRAM** – PRINCIPLES OF PROGRAM IMPLEMENTATION AT SGH WARSAW SCHOOL OF ECONOMICS

The CIVICA Engage Track (CET) undergraduate program is run jointly by the universities associated in the consortium of the European University "CIVICA - The European University of Social Sciences".

The program offers first-cycle full-time students the opportunity to pursue a study path focused on problems that require not only academic knowledge in a given area, but the solution of which also requires social and civic involvement.

CIVICA Engage Track is co-financed by European funds under the Erasmus+ European Universities programme.

The CIVICA Engage Track scheme is shown in the figure below.

## I. General Rules

- 1. CIVICA Engage Track offers three ways to complete the track by selecting one of the following options:
  - 1.1. Option 1: student pursues a CIVICA Engage course at the home university + a CIVICA course at a partner university + prepares a project (Showcase Assignment)

- 1.2. Option 2: the student does the CIVICA Engage course at the home university (SGH) + participates in the European Week + prepares a project (Showcase Assignment).
- 1.3. Option 3: the student does the CIVICA Engage course at the partner university + participates in the European Week + prepares a project (Showcase Assignment).
- 2. Showcase Assignment should take the form of a public speech addressed to an external audience, presenting the student's reflections on an important challenge for Europe, within the selected CIVICA Engage course.
- 3. After completing the CIVICA Engage Track, the student receives a certificate.
- 4. The language of instruction for the CIVICA Engage Track is English. Students pursuing the program have the opportunity to choose subjects in other languages of instruction at partner universities.

## II. Formal requirements for candidates

- 1. At the time of qualification for the program, the candidate must have completed the first year of full-time undergraduate studies at SGH Warsaw School of Economics.
- 2. The eligibility criteria for the program (within each option) are included in the Regulations for qualifying students and doctoral students of the Warsaw School of Economics for trips abroad. - 3. If the student intends to complete the CIVICA Engage course at the partner university during the semester abroad (for which the student may receive an Erasmus+ scholarship), the student must submit an online application during qualification for exchange programs (Erasmus+, PIM and bilateral agreements). If the student is assigned to the program, he or she will have to declare the CET option.
- 4. If options 2 and 3 (semester at SGH + European Week) are selected, the qualification for the European Week takes place outside the online system, while maintaining the same qualification criteria.
