### **EVENT REGULATIONS for "Silent Disco na Spado"**

## § 1 GENERAL PROVISIONS

- 1. These Regulations set out:
  - (1) the admission rules for the "Silent Disco at Spado" event;
  - (2) the rules of conduct and using the venue and the equipment therein by participants in the event;
  - (3) the rights and obligations of the participants.
- 2. The terms used herein have the following meanings:
  - (1) Organiser SGH Warsaw School of Economics with its registered office at al. Niepodległości 162, 02-554 Warsaw, Business Statistical Number (REGON): 000001502, and the Student's Union Association at the SGH Warsaw School of Economics, with its registered office in Warsaw at al. Niepodległości 162/26, 02-554 Warsaw, entered in the National Court Register – Register of Associations and Foundations maintained by the District Court for the Capital City of Warsaw, 13th Commercial Division of the National Court Register under the KRS number 0000236565, Tax Identification Number (NIP): 5213352139;
  - (2) Event Silent Disco at Spado, taking place on 20 May 2025 in Building G of the SGH Warsaw School of Economics;
  - (3) Participant a natural person taking part in the Event, i.e., a student of SGH or a plus one;
  - (4) Venue Aula Spadochronowa (Parachute Hall) in Building G of the SGH Warsaw School of Economics;
  - (5) Guards SGH Serwis Academic Guard.
- 3. Participation in the Event on 20 May 2025 is free of charge; up to 900 Participants may be in the Venue at any time.
- 4. Entry to the Venue means acceptance of these Regulations and the commitment to observe their provisions.

# § 2 ADMISSION TO THE VENUE

- 1. The Event is organised for SGH students. Each student may invite no more than one 'plus one.' The plus one is admitted only when the SGH Student is admitted to the Event.
- 2. Admission to the Venue on 20 May 2025 requires the presentation of an SGH student ID card; this does not apply to the plus one.
- 3. Admission to the Venue is possible after passing the safety inspection specified in § 3 and putting on a wristband.

# § 3 SAFETY RULES

- 1. At the Venue, it is prohibited to:
  - (1) bring and carry weapons or other dangerous items, explosives, pyrotechnics, flammable materials, alcoholic beverages, narcotic drugs or psychotropic substances, subject to § 4(1);

- (2) bring own food and drink, glass and plastic bottles, thermos flasks, etc., and carry-on luggage larger than 42 x 32 x 25 cm;
- (3) bring animals.
- 2. The Guards may refuse entry to the Event for:
  - (1) persons under the influence of alcohol, intoxicants, psychotropic drugs or other similar substances, or suspected to be under such influence;
  - (2) persons carrying weapons or other items, materials, articles, beverages, agents or substances referred to in paragraph 1.
- 3. The Guards may:
  - (1) demand proof of identity;
  - (2) screen a person's luggage and clothing if it is suspected that they are bringing or carrying items referred to in paragraph 1;
  - (3) instruct persons disturbing public order or behaving contrary to the Regulations; and if they fail to comply, order them to leave the Event, and have them removed from the Venue by the security service immediately;
  - (4) apprehend persons posing an immediate threat and/or committing criminal offences to be immediately handed over to the Police.
- 4. The Guards may use means of physical coercion, subject to the applicable legislation on the protection of persons and property and on the conditions and manner of using means of physical coercion by the security personnel.
- 5. The Organiser is not responsible for any belongings left in the Venue.

#### § 4

### ORGANISATIONAL AND ORDER-RELATED RULES AT THE VENUE

- 1. No alcohol is permitted in the Venue.
- 2. Participants must behave in a way which does not pose a threat to the safety of other Participants, observe the provisions hereof, follow the instructions of the Organiser and the Guards and, in particular, observe the bans on:
  - (1) any commercial, advertising, canvassing or fundraising activity without the Organiser's consent;
  - (2) entering or passing through infrastructural facilities, in particular equipment or other building entrances;
  - (3) staying in areas not designated for Participants (in particular on the floors of the building);
  - (4) littering the Venue;
  - (5) destroying the equipment available at the Venue and/or building infrastructure.
- 3. Participants who, in particular, behave aggressively towards other Participants, slander or insult other Participants, violate the personal rights of other Participants, violate the law and good manners, use curses or convey other offensive messages, incite others to dangerous behaviour, pose a threat to the health or lives of other Participants, destroy property, or disturb the Event, will be removed from the Venue by the Guards and handed over to the Police.
- 4. Participants are responsible for damage they cause, in particular injury, theft and material loss at the Venue.

## § 5

### **NOTE**

- 1. The Organiser notes that due to the significant number of Participants and the necessary inspection and security measures applied at the entrance to the Venue, Participants should arrive well in advance.
- 2. Participants may be exposed to constant flashing lights or certain natural combinations thereof.

## § 6 FINAL PROVISIONS

- 1. These Regulations are available:
  - (1) on the website;
  - (2) at the entrance to the Venue.
- 2. The Organiser reserves the right to cancel the Event or to change it for legitimate reasons.
- 3. The Organiser is not responsible for the consequences of any force majeure event. Force majeure is any event beyond the Organiser's control which renders the performance of its obligations impossible or disproportionately costly. Force majeure includes, in particular, bad weather, breakdowns or disruptions of equipment supplying power, heat or light, hostilities or central or local government action regarding policies, laws and regulations affecting the performance of the Organiser's obligations.
- 4. Participants and equipment users ensure order and safety by respecting these Rules and complying with the law.
- 5. Within the scope of the Act of 20 March 2009 on Safety at Mass Events and its implementing rules, the Organiser may record the Event, in particular the behaviour of persons, using audio and video recording equipment. Footage which was collected while recording the Event and may constitute evidence to initiate criminal proceedings or proceedings concerning a minor offence, or evidence of significance for such pending proceedings, is to be immediately handed over by the Organiser to the district public prosecutor having jurisdiction over the Venue or the Police. Footage which was collected while recording the Event and does not contain evidence to initiate criminal proceedings or proceedings concerning a minor offence, or evidence of significance for such pending proceedings, is to be stored after the end of the Event for a period of 30 days from the recording, unless it proves to be necessary to store the footage of a particular incident for a longer time due to obligations under specific provisions. The Organiser is the controller of the personal data processed in connection with video surveillance at the Venue, and the notice on the rules for processing of personal data is located at the entrance to the Organiser's building and at the porters' lodge.
- 6. If there are any changes to the applicable legislation and recommendations of the Chief Sanitary Inspectorate, the Organiser reserves the right to amend the Regulations or enforce sanitary recommendations.
